### From the Executive Director

Earlier this month the Intergovernmental Panel on Climate Change (IPCC) released its Sixth Assessment Report on climate change. In it, the IPCC described how human activity is accelerating climate change and its impacts, with increasing frequency and severity of heat waves, heavy rainfall, and droughts. They warn, "Unless there are immediate, rapid, and large-scale reductions in greenhouse gas emissions, limiting warming to 1.5°C will be beyond reach."

This is an urgent and massive undertaking, and the human-induced climate change impacts we are already seeing are truly an existential threat. The tourism sector must do its part and this past quarter, CREST has responded accordingly with the following:

- Became an early signatory of The Glasgow Declaration, which supports the global commitment to at least halve emissions by 2030 and reach Net Zero as soon as possible before 2050.
- Led a two-day virtual Forum on *Tourism in a Climate Crisis: Taking Practical Action*. This event brought together nearly 200 academics and practitioners from around the world to discuss how to create actionable climate action plans.
- Are coordinating a two-day symposium on crisis and recovery that focuses on climate, biodiversity loss, and livelihoods with IUCN World Commission on Protected Areas Tourism and Protected Areas Specialist Group (TAPAS Group), World Wildlife Fund (WWF), and the Arizona State University (ASU) School of Community Resources and Development.

Transforming the way the world travels in the current climate crisis requires a firm commitment and bold action. We all have a role to play to ensure a sustainable future and thanks to your support, CREST is making a meaningful

difference.

### Taking Practical Action at the World Tourism Day Forum



Another successful <u>World Tourism Day Forum</u> is in the books! On September 28th and 29th, CREST hosted our fifth annual event, this year in partnership with <u>Tourism Declares a Climate Emergency</u> and on the topic of "Tourism in a Climate Crisis: Taking Practical Action." Climate science and experience tells us, as an industry, we must collectively and drastically reduce our greenhouse gas emissions now and in the coming decades. But what does this mean, and how do we get there? This <u>virtual event</u> focused on helping key sectors bridge the disconnect between the goals they are warned must be met when it comes to mitigating the climate crisis, and the action steps they can take to do so. The

event aimed to help participants take positive directional action, no matter where they were in their climate journeys.

Nearly 200 participants joined us for the first day of the Forum, which was open to all and provided information on the path forward for the tourism industry and inspiration from leaders in climate action. Elizabeth Wathuti, founder of the <u>Green Generation Initiative</u>, gave an eye-opening keynote on the urgency and reasons to take action. She was followed by a plenary by Jeremy Smith, co-founder of Tourism Declares a Climate Emergency, on how the tourism community has begun to mobilize. K. Denaye Hinds, CREST Board Member and managing director of <u>JustaTAAD</u>, then moderated a lively panel featuring Janie Neumann of <u>Visit Scotland</u>, Jake Kheel of <u>Grupo Puntacana</u> and CREST board member, and Paras Loomba of <u>Global Himalayan Expedition</u>, who shared their exemplary actions from the destination, accommodation, and tour operator perspectives.

The second day of the Forum featured a plenary session on the topic of "Measurement to Net Zero" offered by Dr. Susanne Etti, Environmental Impact Specialist from Intrepid Travel. Participants were then split into small group technical track workshops for tour operators, accommodations, and destinations, covering the topics of decarbonization, and regeneration. The workshops were facilitated by expert practitioners (check out the list in <u>our program</u> - a HUGE thank you to the facilitators and session assistants), who helped 70 company and destination representatives lay the foundations for their climate action plans. Compiled notes from the technical track workshops will be shared shortly.

And the 2021 Martha Honey Legacy in Responsible Travel Award goes to...





The recipient of CREST's Board of Directors' third annual *Martha Honey Legacy in Responsible Travel Award* is Geoffrey Lipman. He is President & Co-founder of SUNxMalta or Strong Universal Network, a program of EU-based non-profit Green Growth and Travelism Institute that is working to implement the legacy of the late Maurice Strong by promoting climate-resilient impact travel.

Lipman joined the International Air Transport Association in the 1960s and rose to become its Executive Director before his appointment as the first President of the World Travel & Tourism Council from 1990 to 1999. Between 2006 and 2010, he served as Assistant Secretary General and spokesperson of the UNWTO, the World Tourism Organization and prior to that acted as Advisor to the Secretary General. He has served on Boards and Advisory Committees of public and private sector groups in Africa, Europe, the Middle East and Canada, as well as EU Commissions on Airline Liberalization and Tourism Employment.

From a distinguished list of potential candidates for the 2021 award, Geoffrey was selected given his leadership in addressing the current tourism and climate crisis, climate-friendly advocacy, and mentorship in the global travel and tourism industry. We admire Geoffrey's tireless efforts to bring together thought leaders, catalyze action, fill needed gaps, and truly "disrupt" the tourism industry so that we may move the needle towards sustainability.

In many parts of the world, the COVID-19 crisis has led to increased habitat

encroachment, poaching, illegal wildlife trade, and unregulated harvesting, placing an increased risk for zoonotic disease transmission. At the same time, there are ongoing concerns of dramatic increases in COVID-19 induced tourism visitation and waste production in some locales, which also impact public health and visitor management.

This symposium, co-sponsored by the <u>IUCN World Commission on Protected</u> <u>Areas Tourism and Protected Areas Specialist Group</u> (TAPAS Group), Center for Responsible Travel (CREST), <u>World Wildlife Fund</u> (WWF), and the <u>Arizona State</u> <u>University (ASU) School of Community Resources and Development</u>, located in the Watts College of Public Service and Community Solutions, brings together global experts to address some of these challenges and provide examples of solution-oriented outcomes, in the wake of <u>IUCN's World Conservation Congress</u> <u>2021</u>.

### Fiscally-Sponsored Program Updates



**Destination Stewardship Center:** The Destination Stewardship Center released their Summer Destination Stewardship Report at the end of July. The sixth issue, Autumn, is currently under construction. You can see links to all the published issues <u>here</u>. With CREST, the DSC continues to play an active role in the Future of Tourism Coalition and with the Global Sustainable Tourism Council in its Destination Stewardship Working Group.

**CARE for Cape & Islands:** <u>CARE for the Cape & Islands</u> is hosting its seventh annual CARE for the Cape & Islands Day on Thursday, October 21. All businesses located in the Cape Cod and Islands area are invited to participate in a half day of hands-on volunteer service benefiting <u>Chatham Drama Guild</u>, a local theater that has operated for more than 80 years. Businesses will also learn about CARE's mission to preserve and protect the natural, cultural, and historical treasures of Cape Cod, receive a tour of the facility, and hear a presentation from CARE grant recipients. <u>Registration is required</u> along with a \$25 donation to support CARE's grant program.

**Torres del Paine Legacy Fund, Chile:** In August and September, Torres del Paine Legacy Fund with support from the Intrepid Foundation and CREST, launched a Call for Proposals from organizations, businesses, and projects based in Puerto Natales, Chile. In an effort to address revenue losses created by the pandemic, the Legacy Fund and Intrepid Foundation will provide micro-grants ranging from USD \$4,500 - \$6,000 to fund between 3-4 projects or businesses for a more sustainable future for Torres del Paine National Park and its surrounding communities.
